LEDVANCE warrants each LEDVANCE ballast (when installed in a compatible and suitable LED system) (the "Product") to be free from defects in materials and workmanship, and to operate from the date of installation (or date of manufacture if installation date is not known or available or verifiable) for the time periods and subject to the Terms and Conditions specified below. LEDVANCE further warrants that , for one (1) year the functionality of the firmware embedded in the Product(s) "Product Firmware") will conform in all material respects to the Product documentation available at the start of the warranty period.

If the Product fails operate during the applicable warranty period due to a defect, LEDVANCE will, at its option, replace or repair the Product. LEDVANCE reserves the right to utilize new, reconditioned, refurbished, repaired, or remanufactured Product(s) or parts in the warranty repair or replacement process. For purposes of clarity, this Limited Warranty does not include any removal, commissioning, programming, or reinstallation costs or expenses, including without limitation, any labor costs, equipment, or other expenses required to remove and/or reinstall original or replacement Product(s) and/or parts. This Limited Warranty extends only to the Product(s) as delivered to, and is for the sole and exclusive benefit of, the original end-user of the Product(s) at the original location. This Warranty may not be transferred or assigned by the original end-user. The repair or replacement of any Product(s) or component part within the Product(s) is the sole and exclusive remedy for failure of the Products to comply with the terms of this Limited Warranty and does not extend the Warranty Period. If product is not available LEDVANCE will grant Purchaser a credit to be used for replacement product on a pro-rated basis according to the following calculation for credit to be applied, purchaser must have purchased directly from LEDVANCE, otherwise replacement product will be provided as a remedy.

(UL), Standards for the American National Standards Institute (ANSI) or the Canadian Standards Association (CSA). This warranty does not apply in the event of conditions demonstrating abnormal use or stress, including under/over voltage/current conditions, power surges or spikes, excessive switching cycles or operating hours, or outside the following recommended operating conditions:

- Warranty period is based on typical 8,760 hr./yr. operation on a continuous cycle of 24 hours
- Do not exceed the Tc point (or case temperature) specified in the product specifications for warranty as set forth above.
- Measures must be in place to prevent lightning strikes or transients at the input of the power supply if intended to operate above the rated transient protection of the power supply.
